The significant inspiration in creating products such as clothing, art sculptures, weapons, architecture, food, dance, and civilization. The objective is to facilitate the student by measuring the tendency during producing and developing the research for fashion design portfolio inspiring from suitable characteristics elements and principles by sustaining the authenticity of Malaysian art culture. This study used a quantitative method with a questionnaire that was descriptively analyzed with up to 92 respondents. Based on the tendency result 96 % showed that it will suit syllabus requirements. The overall result will upgrade the guidelines and improvements in the syllabus apparently with to achieve the conditions of sustainability in Quality Education Practices (SDG4) and Decent Work and Economic Growth (SDG8) as recommended in the SDG17 plan and contribute to ensure that it can have an impact in empowering the knowledge and skill of students suitable with the demands of the local fashion industry in Malaysia.

3. Inspiration Board developments Ideation




Figure 1. Traditional Element Brief Chart




Figure 2. Design Research Flow Chart




Figure 3: Statistic of total respondent percentage survey in Politeknik Malaysia source by Author.

In section A, the chart above shows that the percentage of respondents in semester 03 is the highest stating 35% (n=32 respondents), followed by semester 05 33% (n=30 respondents) and the lowest in semester 02 18% (n=17 respondents) and 04 stated 14% (n=13 respondents). It is proved that most of the respondents in each semester practiced by selecting Malaysian Art and culture as their main inspiration while proposing their research in fashion design studies.




Figure 4: Statistic of Basic knowledge of the elements and principles of Malaysian art and culture inspired in the Development of the ideas in fashion studies source by Author.

However, in section B, the highest Percentage of Knowledge score in the medium class was around 74% (n=68 respondents), high-class percentage showed that only 22% (n=20 respondents) and the lower class stated 4% (n=4 respondents) from 92 total respondents. 


Figure 5: The Percentage of Inspiration that influenced respondents' choices to explore in inspiring the study of fashion inspired by Malaysian Art.

In Section C, the chart above showed that the highest score of respondent's interest is the Garment/Craftsmanship category around 62% (n=57 respondents). Traditional Food stated at 14% (n=13 respondents), Architecture 10% (n=9 respondents), Game & Weapon recorded at 9% (n=8 respondents) and finally Performing Art & Folklore Story category 5% (n=5 respondents). From this segmentation of category type of interest, it is proved showed all these categories have influenced the respondents to choose and explore the study of fashion inspired by Malaysian Art and Culture, especially in the design development process.




Figure 5: The Percentage of respondents' tendency if elements and principles in Malaysian art and culture are used as inspiration in the compulsory study of fashion design.
