Need: Another element of crime is need. People commit white-collar crimes for satisfaction. Support their ego or their family.


Sutherland's definition of white-collar crime has been criticized in some quarters.

They created a speculative market by borrowing heavily from banks and buying scrips at overpriced prices Mehta and his brothers were arrested by the CBI on 9 November 1992 for



misappropriating 2.8 million shares of around 90 companies through forged share transfer forms. The total value of the share swap was put at ₹250 crore

The intensity of the Harshad Mehta scam would have been so huge that from today's perspective, it would have been worth looking at the market in Dalal Street. Looking at the figures, one person defrauded the entire nation to the tune of Rs 24,000 crore

The scale of the Harshad Mehta scam was so great that it shook Dalal Street in today's perspective. If you look at the numbers, this one man cheated the entire country to the tune of Rs 24,000 crores (which is bigger than Nirav Modi or Vijay Mallya's scams)

He was a charismatic man, fluent in several languages and he befriended the girls, mentoring them, first spiking their drinks. Later he used to steal all the cash and valuables from them

Sobhraj claimed that most of his murders were caused by accidental drug overdoses of temazepam and heroin, but investigators say that the victims threatened to expose Sobhraj, which was the motive for his murders.

The words of Charls Shohraj said "I've never killed anyone in my life. His tone was typical, even as he said: "I have taken the passport, used the passport, stolen some money. But I never killed people." Shubhra alleges that he was framed for the murders and had never entered Nepal before 2003. He claims he is a "victim" of what he says is a corrupt criminal justice system.

Statement of accused

A rapist lodged in Tihar jail claimed that a 5-year-old girl 'provoked' him to rape her.

Madhumita Pandey, Doctoral Ph.D. A student in Britain conducted research by interviewing 100 rapists in Tihar. This 23-year-old man was one of them.

When she further asked him how the 5-year-old girl provoked him, he said that the younger girl touched him inappropriately, so he decided to teach her a lesson. She was a small beggar who used to sit outside the temple.

When asked further he said that his only regret was that the girl was no longer a virgin, hence no longer 'pure', so he planned to marry her as soon as he came out of jail.

Pandey concluded the following after his research:

Very few rapists were educated or graduated from high school.

She expected them to be monstrous and paranormal, but to her surprise, they seemed normal.

She says, "When you talk to [rapists], it shocks you – these people have the power to make you feel sorry for them. As a woman, you don't expect to feel that way. . I would almost forget that these men have been convicted of raping a woman. In my experience, a lot of these men don't realize that what they have done is rape. They don't understand what consent is.
