In Kerala after the transgender policy (2015) the community visibility increases and majority of members reveal their gender identity and comes to mainstream of society. Transgender individual putter their signature on every sector of society amaost of them are engaged in film field, started own business, beautician works and their value increased day by day. Transphobia of society slowly decreased. Most of the transgender individuals are dropped out from school due to the physical and mental abuses from the teachers and students. So the Transgender individuals faced other major issue was lack of Education. A suvey were conducted to identify the percentage ,The survey found only 1.2 percent of the transgender individuals were unable to read or write. The number of school dropouts among transgenders increased as they progressed to higher classes, mostly due to social stigma. Not only that 10.61 percent dropped out of school between classes 1V and V11, around 40 percent dropped out between classes V11 and X. Among the transgender individual surveyed, 26.55 percent had passed the plus Two course. While 13.60 percent transgenders were graduates 2.10 percent were post graduates. Inorder to help the school dropouts continue their education, Social Justice Department has implemented scholarship scheme for Transgenders an amount of **Rs 4,000**/- as financial assistance to Transgender community as rent for finding hostel facility and accommodation.

To address these challenges, the Kerala State Literacy Mission Authority (KSLMA) initiated an exclusive literacy program for the well-being of the transgender community. Leveraging existing equivalency courses and other programs, the Literacy Mission aimed to inclusively involve transgender individuals. Special classes were conducted in each district with support from civic authorities and continuing education centers. Complementing the literacy mission, skill development programs were introduced for the community. KSLMA sought active support from the Social Justice Department for the successful implementation of this initiative and explored collaboration to establish hostels, providing a safe environment for transgender individuals to pursue education.

Recognizing that many transgender individuals face unemployment and resort to prostitution due to a lack of awareness, the focus on education became paramount. A proper education not only fosters personal, professional, and social growth but also instills joy, curiosity, and a deep desire to contribute positively to society. The goal was not only to solve immediate issues but also to inspire leadership roles among transgender individuals.

Following the education-focused efforts, the next strategic plan involved availing government benefits through transgender identity cards. To counter fraudulent claims, the Social Justice Department rolled out an initiative to provide identity cards for transgender persons, ensuring that the benefits of government

welfare schemes reached genuine beneficiaries. Application forms included a separate column for transgender individuals, and transgender-friendly toilets were implemented.

There was a move towards enabling the direct transfer of funds for Sex Reassignment Surgeries (SRS) to private hospitals by the government. These accomplishments collectively elevated the status of transgender individuals in Kerala. Additional milestones included India's first gender-neutral football league, the formation of a Justice Board for transgender welfare, the provision of free sex reassignment surgeries, the establishment of a school for transgenders in Kochi, and the initiation of the first-ever beauty pageant for trans-women. These diverse developmental initiatives contributed to the upward movement and empowerment of the transgender community..

#### **Social Attitudes and Awareness:**

Through in-depth interviews and participant observation, it was revealed that increased visibility in her community was closely linked to her active involvement in community events and educational initiatives.
