- The <u>physical constant</u>  $\varepsilon_0$  (pronounced as "epsilon nought" or "epsilon zero"), commonly called the vacuum permittivity, permittivity of free space or electric constant or the distributed capacitance of the vacuum, is an ideal, (baseline) physical constant, which is the value of the <u>absolute dielectric</u> permittivity of classical vacuum.
- Its <u>CODATA</u> value is  $\varepsilon_0 = 8.8541878128(13) \times 10^{-12} \,\mathrm{F \cdot m^{-1}}$  (<u>farads</u> per <u>metre</u>), with a relative uncertainty of  $1.5 \times 10^{-10}$ .
- It is the capability of an <u>electric field</u> to permeate a vacuum. This constant relates the units for <u>electric charge</u> to mechanical quantities such as length and force.
- Relative permittivity is typically denoted as  $\varepsilon_r(\omega)$  (sometimes  $\kappa$ , lowercase <u>kappa</u>) and is defined as  $\varepsilon_r(\omega) = \frac{\varepsilon(\omega)}{\varepsilon_0}$
- where  $\varepsilon(\omega)$  is the <u>complex</u> frequency-dependent <u>permittivity</u> of the material, and  $\varepsilon_0$  is the <u>vacuum</u> permittivity.
- Relative permittivity is a dimensionless number that is in general complex-valued.
- The relative permittivity of a material for a <u>frequency</u> of zero is known as its static relative permittivity.

- Relative permeability, denoted by the symbol  $\mu_r$ , is the ratio of the permeability of a specific medium  $\mu$  to the permeability of free space  $\mu_0$ :
- In <u>physics</u>, the fine-structure constant, also known as Sommerfeld's constant, commonly denoted by  $\alpha$  (the <u>Greek letter alpha</u>), is a <u>fundamental physical constant</u> characterizing the strength of the <u>electromagnetic interaction</u> between elementary charged particles. It is a <u>dimensionless quantity</u> related to the <u>elementary charge</u> e, which characterizes the strength of the coupling of an elementary charged particle with the <u>electromagnetic field</u>, by the formula  $4\pi\epsilon_0\hbar c\alpha = e^2$ . As a <u>dimensionless quantity</u>, its <u>numerical value</u>, approximately 1/137, is independent of the <u>system of units</u> used.
- When the other constants (c, h and e) have defined values, the definition reflects the relationship between  $\alpha$  and the permeability of free space  $\mu_0$ , which equals  $\mu_0 = 2h\alpha/ce^2$ . In the 2019 redefinition of SI base units,  $4\pi \times 1.00000000082(20) \times 10^{-7} \text{ H} \cdot \text{m}^{-1}$  is the value for  $\mu_0$  based upon more accurate measurements of the fine structure constant.
- In <u>electromagnetism</u>, permeability is the measure of the resistance of a material against the formation of a <u>magnetic field</u>, otherwise known as distributed inductance in <u>transmission line theory</u>. Hence, it is the degree of <u>magnetization</u> that a material obtains in response to an applied magnetic field. Magnetic permeability is typically represented by the (italicized) Greek letter <u>μ</u>. The term was coined in September 1885 by <u>Oliver Heaviside</u>. The reciprocal of magnetic permeability is magnetic reluctivity.
- In <u>SI</u> units, permeability is measured in <u>henries</u> per meter (H/m), or equivalently in <u>newtons</u> per <u>ampere</u> squared (N·A<sup>-2</sup>). The permeability constant  $\mu_0$ , also known as the <u>magnetic</u> <u>constant</u> or the permeability of free space, is a measure of the amount of resistance encountered when forming a magnetic field in a classical <u>vacuum</u>. Until 20 May 2019, the magnetic constant had the exact (defined) value  $\mu_0 = 4\pi \times 10^{-7} \text{ H/m} \approx 12.57 \times 10^{-7} \text{ H/m}$ .
- On 20 May 2019, a <u>revision to the SI system</u> went into effect, making the vacuum permeability no longer a constant but rather a value that needs to be determined experimentally;  $4\pi \times 1.00000000082(20) \times 10^{-7} \, \text{H} \cdot \text{m}^{-1}$  is a recently measured value in the new system. It is proportional to the dimensionless fine-structure constant with no other dependencies.

- So  $\sqrt{\mu_0 \hat{x}} \times \sqrt{\epsilon_0 \hat{y}} = 3.33 \times 10^{-9} \hat{z} \frac{s}{m} = 3.33 \hat{z}$  ns/m (nano second per meter).
- Hence reaction time per meter for nano sized particle is  $1/c = 3.33 \times 10^{-18}$  second = 3.33 attosecond.
- Hence nano particles of size 3.33 nano meter possess entire different character to their macro size particles that is to say nano particles behave differently to the electrical and magnetic field and are highly dynamic in nature.

## **Proof from Astrophysics**

Consider the atomic model an electron circulating the nucleus containing proton i.e. Hydrogen atom model. There are two attractive forces i.e. gravitational attraction because of masses of proton, electron and the coloumb attraction because of opposite charges of the two particles. These forces are balanced by the centrifugal force because of the revolution of electron around the proton viz.
